



## MEMORANDUM OF UNDERSTANDING

# BETWEEN Stanford University through its Center for Innovation in Global Health (CIGH) and Department of Pediatrics and

Organismo Andino De Salud Convenio Hipolito Unanue (Oras Conhu)

This Memorandum of Understanding ("MOU"), is entered into this day of xxxxx ("Effective Date") between Stanford University (acting for and on behalf of its Center for Innovation in Global Health and the Department of Pediatrics) based in Palo Alto, California, U.S.A. ("Stanford" or "Stanford CIGH" or "Stanford Pediatrics") and the Organismo Andino de Salud Convenio Hipolito Unánue ("ORAS CONHU") in Lima, Peru. Stanford and ORAS CONHU are referred to herein as a "Party" or as an "Institution," and together as the "Parties" or "Institutions."

WHEREAS, the Institutions have successfully worked together over the past several months; share a common vision to provide evidence-based insights and recommendations for maternal, child and adolescent health and public health, and wish to foster their collaborative relationship to continue to provide evidence-based insights and recommendations to hold the world to account to accelerate a more equitable and effective system of health care and to build stronger, resilient health and public health systems globally.

NOW, THEREFORE, the Institutions, wishing to promote a cooperative relationship, agree as follows:

### ARTICLE 1: SCOPE OF COLLABORATION

- 1.1 General Scope. Each Institution may offer to the other opportunities for activities and programs that will foster a collaborative relationship.
- 1.2 Specific Activities. Specific activities and programs implemented under authority of this MOU shall be subject to availability of funds and the approval of each Institution's authorized representatives. The Institutions contemplate implementation of programs or activities such as:
  - (a) Joint Research, Insights, and Knowledge Sharing
    Co-develop and jointly disseminate research and insights to support equitable access to
    health systems, and to strengthen maternal child and adolescent health and well-being
    and promote effective and resilient health and public health systems.
  - (b) Joint Events





- i. To raise awareness of respective efforts, both Institutions may promote each other's work and the collaboration via press release, website and/or events.
- ii. Both Institutions will consider opportunities for joint programming/events as well as other mutually beneficial projects/activities, such as a co-hosted eventss. The Parties may agree to invite like-minded collaborators to join.

# (c) Joint Steering Committee

- The Parties may participate in periodic Global Network Steering Committee meetings with other Global Network members to provide perspectives and inform program direction.
- 1.3 Responsibilities. Each Party will be responsible for its own costs and expenses incurred in connection with this MOU unless otherwise agreed upon in writing.
- 1.4 Specific Agreements. Prior to initiating any specific activity or program, the Parties will negotiate and enter into a specific agreement, signed by each Party's authorized signatory, describing the terms of the arrangement, including the budgets. Each Party will designate a Liaison Officer in any specific agreement to develop and coordinate specific activities or programs.

# ARTICLE 2: RENEWAL, TERMINATION AND AMENDMENT

- 2.1 Duration. This MOU shall remain in force for three years from the date of the last signature. Either Party may terminate this MOU by providing 60 days' advance written notice to the other Party.
- 2.2 Extension and Renewal. The Parties may extend or renew this MOU by agreement, confirmed in a written amendment signed by each Party's authorized signatory.
- 2.3 Amendment. No amendment of the terms of this MOU will be effective unless made in writing and signed by each Party's authorized signatory.

# **ARTICLE 3: GENERAL MATTERS**

3.1 Use of Names. Neither Party may use the name, abbreviation of the name, logo, seal, or any other trademark of the other Party in any form of advertising or publicity without such other Party's express written permission. The Parties must seek permission from one another by submitting the proposed use, well in advance of any deadline, to the liaison officers designated in Article 3.2 below. Any use of Stanford's name, brand, tradename, trademark, logo, symbol, terms referring to Stanford, images of Stanford buildings or landmarks, or the name, title, likeness, or any statement of a faculty member, employee, or student of the other Party's must adhere to Stanford's Name Use Guidelines (https://trademarks.stanford.edu/name-use-guidelines).



3.2 notices. The Parties must give all notices under this MOU in any of the following ways: (a) hand delivery (b) certified mail, return receipt requested; or (c) electronic mail, with conformation of delivery by recipient. All communications must be sent to the addresses set forth below or to such other address designated by the Parties by written notice. Notices are effective upon receipt and evidence of delivery.
